





TMALI has in the past nine years offered the following comprehensive short-learning courses, which programmes are currently undergoing review to assess their relevance and impact to Africa's current challenges and search for own solutions:

- Thought Leadership for Africa's renewal;
- African Political Economy. The African Economic Challenge;
- Africa and International Trade Building an African Developmental State;
- Democracy and Governance in Africa;
- African Feminist and Gender Studies;



Public Policy and analysis for Africa's Development.

As part of its community engagements, TMALI fulfils these through Colloquia, Seminars, Roundtables and Conference tackling various scholarly topics.

During 2018 and 2019, as part of its mandatory review process, an internal and external review process was commissioned to look at the performance of the institute over the initial half a decade of its establishment. The Review process was led by the renowned scholars, Professor Sibusiso Vil-Nkomo and Dr Tania Abrahams

The Panel recommended the establishment of a Comprehensive Graduate School, which indeed established on the 1st May 2020 and Launched formally to the public on the 22<sup>nd</sup> September 2020, under the name Thabo Mbeki School of Public And International Affairs (The TM School).

The TM School incorporates Thabo Mbeki Leadership Institute (TMALI), Institute for Dispute Resolution (IDRA), Institute for African Renaissance Studies (IARS), South African Democracy Education Trust (SADET), and Thabo Mbeki Presidential Library (TMPL).

The School is an expression of Partnership between the Foundation and the University of South Africa. It is established to be a magnet of excellence in Teaching, Learning and Research on the matters of Public and International Affairs.

Professor Vil-Nkomo is the first Head of the TM School, tasked with curriculum development, recruitment of the Academic core, establishment of partnerships and the development of the site where the physical structure of the School is to be built at the identified site at Irene.

The School is governed by the TMF and UNISA Board which is co-chaired by Dr Brigalia Bam and Professor Makhanya, the Chair and Vice-Chancellor of the Foundation and Unisa respectively.

# Examining the African Continental Free Trade Area in the Context of a Political Federation for Africa – Towards a United African States

#### Abstract

This paper deals with the African Continental Free Trade Area (AfCFTA). which was founded on 21 March 2018, and the creation of an African Economic Community (AEC) as envisaged in the 1991 Abuja Treaty. The AfCFTA and the AEC are potential steps towards the political federation of African countries into a single African nation. The paper highlights critical issues pertaining to the AfCFTA and proposes an effective implementation plan, including options for dealing with the Regional Economic Communities (RECs), the customs unions, the monetary communities and the Tripartite Free Trade Area (TFTA). Overall, the AfCFTA does not have a good chance of success because - among other reasons - political commitment is not always firm in similar initiatives and also the TFTA has gained a lot more traction to a point that it is highly likely to be better implemented than the AfCFTA. The AfCFTA is, as is the TFTA, a critical step towards the creation of an AEC and in turn a potential stage towards a political federation of African countries into a single African nation. The paper makes a case for a United African States (UAS), that is, a political federation of African and Caribbean countries into a single African nation. The UAS is the answer to the many problems that African (and Caribbean) countries face, largely because these countries were wrongly carved up into "nations" when in fact there can only be one African nation rather than many so-called nations in Africa. Indeed, there can be many cultural groups as has always been the case, prior to the 1884/5 Berlin Conference which created countries and micro-states that cannot advance development for their countries/peoples.

first of its kind of the African continent, the Thabo Mbeki Presidential Library (TMPL) is another expression of partnership between the University of South Africa (UNISA) and the Thabo Mbeki Foundation. It aims to be an African Centre of Excellence in learning, research, and discourse for the transformation of Africa.

It will connect to similar centres on the globe, whose aim is to drive advances towards the Renaissance and unity of Africa. It will be a repository of former President Thabo Mbeki's documents, papers, artefacts, and all materials.

TMPL is intended to become a "living library and museum", which will not only focus on the life and times of former President Mbeki, but also on the larger context in which President Mbeki's activities took place.

The life and times of President Mbeki represent one of the unique opportunities to examine the history of the liberation of Africa. The Thabo Mbeki Presidential Library would therefore be:

- a centre of excellence in African knowledge;
- a place for African scholarship;
- an interactive space for reflection;
- an accessible centre of knowledge;
- a place where Africans get to know and write their own history;
- a place to learn what shaped the society that we currently live in;
- a centre for inter-generational engagement;
- a place where the world and African diaspora will better understand Africa;
- a place where people get to understand President Mbeki and the ideas that shaped his thinking; and
- a place for personal reflection and connecting with self through cultural and other activities.



More importantly the TMPL will provide a place for experiential learning as part of the TM School.

The TMF and UNISA has, while awaiting the building of a permanent home for the TMPL, created a prototype of the Library. The prototype, which houses some of President Mbeki's material, is hosted at the UNISA main campus in Pretoria.


Since its launch, the TMPL has a high number of visitors on a regular basis, consisting of journalists, policy makers, publishers, researchers, and students, local and abroad. To date, over 18 000 visitors have been logged onto the TMPL database.

The TMF is currently in a resource mobilisation drive to ensure launching of the virtual phase of the Library and Museum and the commencement of construction by  $4^{th}$  quarter of 2021 and eventual completion by 2024.

There has been tremendous support for this Project, especially from among young people who identify the TMPL as the repository of their history and heritage. In aide of the ongoing efforts to ensure the success of resource mobilisation efforts towards the building of the library, young people from various parts of South Africa, in 2019, took it upon themselves to host fundraising dinners in Johannesburg and Cape Town.

The year 2019 was closed with a generous show of support by the legendary jazz musician and activist, Abdullah Ibrahim, through

To ensure the success of this effort, the Foundation has been joined by the world-renowned African Architect, Sir David Adjaye as the leader of the architectural design process. He will be working the South African based architects, MMA Design Studio. This creative duo will be complimented by a construction team comprised of highly knowledgeable young professionals who bring with them many years of experience and skills in the construction sector.


The TMPL designs were unveiled by the Patron and Sir David Adjaye on the Event hosted by the Foundation in Houghton on the 19 November 2020. There has been a positive response to this Project since then and the Foundation is co-ordinating various resources mobilisation efforts including collection of material relevant to the Library.

The South African Government is fully supportive of the Project and President Ramaphosa has designated Hon Minister Nathi Mthethwa to provide the necessary support to the Project including the material support. 

## **SOUTH AFRICAN DEMOCRACY EDUCATION TRUST**

he South African Democracy Education Trust SADET was established as a project Trust after President Thabo Mbeki indicated his concern about the paucity of historical material on the arduous and complex road to South Africa's peaceful political settlement after decades of violent conflict.

SADET's mission is to examine and analyse events leading to the negotiated settlement and democracy in South Africa with a focus on:

- The events leading to the banning of the liberation movements.
- The various strategies and tactics adopted in pursuit of the democratic struggle.
- The events leading to the adoption of the negotiation strategy.
- The dynamics underpinning the negotiations process between 1990 and 1994.


The study resulted in, amongst others, the publication of 5 volumes of research covering the successive decades in the run up to the first democratic elections, including an overview volume.

- The Road to Democracy: South Africans telling their stories, Volume 1, 1950 1970;
- The Road to Democracy in South Africa, Volume 2, 1970 1980;

- The Road to Democracy in South Africa, Volume 4, 1980 1990 (Part 1, 2 and 3\*);
- The Road to Democracy in South Africa, Volume 5, African Solidarity;
- The Road to Democracy in South Africa, Volume 6, 1990 to 1996 (Part 1 and 2);
- The Road to Democracy in South Africa, Volume 7, commemorates the 40th; and
- The Road to Democracy Volume 8, Explores the movements of Peoples in the Sub-Sahara and the extent of the interrelationships.

The Foundation is exploring the relations with the Departments

of Arts and Culture and that of Basic Education to turn these Volumes into School textbooks, the basis upon which History will be taught. The SADET Project now forms an integral and necessary part of the TM School Research Unit.





## THABO MBEKI ANNUAL AFRICA DAY LECTURE

n the 25th of May each year, the TMF and UNISA host the Thabo Mbeki Africa Day Lecture to reflect on various challenges facing the African continent and the world. This platform also provides an opportunity for South Africans to interact with other Africans from beyond South Africa's borders, to share and shape ideas about shared challenges and prospect of our future as Africans.

#### 2018

Since the Patron, President Thao Mbeki, delivered the inaugural lecture 10 years ago, the Thabo Mbeki Africa Day Lecture has become the premier event on the African calendar marking the birth of the OAU/AU. Each year, the lecture is delivered by distinguished African, and is meant to focus on the state of the African Continent, its challenges, and the practical steps to respond to these.

In the year 2018, the Lecture was delivered by

the distinguished former Deputy President of the Republic of South Africa and current Executive Director of UN Women, Dr Phumzile Mlambo-Ngcuka.

The theme of her address was on "Gender Equality and Women Empowerment: A Nec-

essary Paradigm Shift in Africa's Quest for Development and Poverty Eradication". The lecture located the confluence of factors impeding the African countries' advance towards gender equality within the global context.

While recognising the numerous advances in the form of policy legislation passed at various multilateral, both at regional and continental level, it was agreed that these have scantily been translated to actionable programmes at member states level. Thus, the need for regeneration of a vigilant civil society movement on the Continent to provide the necessary oversight and promote the gender mainstreaming – should undergird these efforts.

#### 2019

To mark the 10th anniversary of the Thabo Mbeki Annual Africa Day, we had the honour of hosting the former Prime Minister of Ethiopia, HE Hailemariam Desalegn. The Lecture was held under theme "The National Question, Peace and Democracy".

The lecture explored the unresolved challenge of managing diversity, which remains a defining feature of the process of state formation and nation building in post-colonial Africa, even as countries insist on their national unity and territorial integrity.



It was generally agreed that many countries on the continent, including South Africa, face the challenge to respond to the task of ensuring unity in diversity, thus, to guarantee equality among all national, ethnic, cultural, linguistic, and religious groups, which in turn, underwrites the achievement of social cohesion, peace, and democracy in our respective countries.

Due to challenges relating to the Covid-19 pandemic restrictions and related uncertainties the 2020 Africa Day Lecture was postponed to 2021, due to be delivered by the Patron.



## **INTERNATIONAL WOMEN'S DAY**

he TMF's Annual International Women's Day (IWD)
Dialogue draws its inspiration from the globally recognised 1909 and 1911 women's protests in the United States and Europe respectively. The purpose of the IWD Dialogue is to locate contemporary struggles faced by women, especially in Africa, in a merged past, present and future context, which undergirds proffered practical solutions.

#### 2019

In the year 2018, the IWD Dialogue hosted Dr Ameenah Gurib-Fakim, the former and first female President of Mauritius. Dr Gurib-Fakim was joined in a panel by then South African Minister of Science and Technology, Mrs Khensani Kubayi-Ngubane and Ms Lerato Motsamai, the Chief Executive Officer of Petrolink. However, there were still many challenges that militate against the achievement of gender equality, including the quality and continent of education.



In the year 2018, the IWD Dialogue hosted
Dr Ameenah Gurib-Fakim, the former and first
female President of Mauritius. Dr Gurib-Fakim
was joined in a panel by then South African
Minister of Science and Technology, Mrs Khensani
Kubayi-Ngubane and Ms Lerato Motsamai, the
Chief Executive Officer of Petrolink.

The discussants argued for a gendered approach to investment in research and harnessing of the opportunities presented by the 4th Industrial Revolution to further bridge the gender gap. It is thus important that both government and the private should implement a coordinated gender mainstreaming approach to policy formulation and implementation.

#### 2020

The International Women's Day Event was held at the Turffontein Racecourse, attended by at least 750 guests.

The Guest Lecturer was Dr Samar Jabr from Jerusalem. Her presentation focused on the theme, "Rewriting of Women back into History", using the impact of violence on the generations of Women in Palestine.

A panel discussion, which included Ms Beneke-Thomas (UNDP) and Ms. Linet Muriti-Otieno (AFDB), elicited an intense discussion from the audience.

The Foundation has hosted the Dialogues for the past 10 years and is now producing a Commemoration Book of the past 10 years to influence scholarship, policy, pragmatic programmes, and Advocacy on gender discourse. The book will be launched in March 2021 to coincide with the International Women's Day Commemoration.



## **CONCERNED AFRICANS FORUM**

he TMF recognises the need for a think tank and intervention vehicle to respond to challenges facing the African Continent. The idea culminated in the setting up of a Forum, referred to as Concerned Africans Forum, drawing experience from various progressive Africans around the Continent, united by their common concern about the Continent *vis-à-vis* its position in the World as both the Think-Tank and also interventionist forum on African Affairs.

CAF has held Dialogues and hosted Speakers on wide-ranging matters relating to Nigeria, Liberia, Zimbabwe, the DRC, and South Africa.

#### National Foundations Dialogue Initiative

The National Foundations Dialogue Initiative (NFDI) is an initiative of Chief Albert Luthuli Foundation, Robert Mangaliso Sobukwe Foundation, Desmond & Leah Tutu Legacy Foundation, Thabo Mbeki Foundation, F W de Klerk Foundation, Helen Suzman Foundation, Umlambo Foundation and the Jakes Gerwel Foundation, born out of a common grave concern shared by all South Africans that there is much that is going wrong in our country which must be addressed as a matter of urgency.

Thus, the afore-mentioned Foundations came to the firm conclusion that it is necessary and urgent that South Africans should engage one another in a National Dialogue exactly to arrive at a new national consensus to address this new National General Crisis.


On October 2019, the NFDI in partnership with the Human Science Research Council and the Institute for Justice and Reconciliation hosted a Constitutional Dialogue at the Parliament of the Republic of South Africa.

It sought to bring together members of the Executive, the Legislature, the Judiciary, religious bodies, and other members of civil society to engage in constructive conversation around their responsibilities, jointly and severally, under the Constitution.

The NFDI continues to explore such difficult areas that confronts our country be it corruption, service delivery failures and now the impact of Covid-19 pandemic through the process of courageous dialogues.





## YOUTH PROJECTS AND THE YOUTH HUB



he TMF recognises that Africa is a youthful Continent, with over 40% of its working age population between ages 15 and 24. Africa's future therefore depends on the direction that its youth follow today.

In 2016, the TMF established the Thabo Mbeki Youth Hub, as a consolidation of all Youth formations who are committed practically and concretely to advance Africa's renewal. The thrust of the Youth Hub, among other things, is to harness the energies of young people on the African Continent for progressive change.

On September 14, 2018, the TMF in partnership with Heavy Chef, hosted a youth dialogue on the 4th Industrial Revolution (4IR) and its impact on education and the world of work. At the end of the dialogue, the Patron issued a challenge to the youth to conduct a study of the 4IR, its attendant consequences for South Africa and proposals to improve training of educators, the better to transform teaching and learning in our schools.

Accordingly, a Working Group tackling the complex question of what practical steps South Africa needs to take to lay the foundation for the future of education in the 21st Century, comprising of experts drawn from various fields related to education, was established to respond to the challenge issued by the Patron. The

working group presented its Research Report ( *Working Paper on the 21st Education*) a year later, in September 2019, at the President Hotel in Cape Town

#### Public Dialogues/ Seminars

Following the publication of the TMF's paper in September 2018, titled, What the about Land Expropriation without Compensation? The National Democratic Revolution Must Resolve the Intimately Inter-Connected Land and National Questions, the paper redirected and broadened the debate on the Land and National Questions and the urgency for South Africans to resolves these challenges.

To further sustain, deepen and broaden the debate, the Foundation hosted a seminar at Wits University in partnership with

the Southern Center for Inequality Studies. The seminar explored the political history overview of South Africa's land debate, interrogated the structural barriers to equitably distributing the land and engaged feasible solutions under the current South African Constitution.

The discussions were led by a panel comprised of ANC Veteran, Mr Mavuso Msimang, Dr Aninka Claassens, Director of the Land & Accountability Research Centre (LARC), Faculty of Law at the University of Cape Town and Adv Tembeka Ngcukaitobi, a lawyer and a member of the South African Law Reform Commission (SALRC.


Driven by a genuine concern engendered by various threats to our human rights system on the African continent, the TMF in partnership with the South African Human Rights Commission (SAHRC), the Center for Human Rights and the University of Pretoria, hosted a two-day seminar to iinterrogate the status of the African Court on Human and People's Rights, as well as the Independence of the African Commission. The seminar series took place on September 11 – 12, 2019 at Protea Fire and Ice Hotel in Pretoria.

Aptly titled, Global and Regional Accountability Mechanisms: Focusing on the as well as the African Commission, the first of the two days' seminar series reviewed Africa's human rights record, the African Union and its member states' relationship with the International Criminal Court (ICC) and the efforts made thus far to affect the Malabo Protocol and whether the African Court can provide an alternative to the ICC.

The second day discussed the independence of the African Commission on Human and People's Rights, the attendant challenges and the to strengthen strengthen dialogue, cooperation and collaboration between the African Union organs and the African Commission as well as ensuring that state parties submit their periodic reports and participate actively in sessions of the African Commission.

Book Launches.

The Foundation, in a partnership with the University of Johannesburg's (UJ) Institute for Pan-African Thought and Conversation (IPATC) and the UJ Library hosted a launch of its book titled "Building Blocks Towards an African Century: Essays in Honour of Thabo Mbeki Former President of South Africa" (edited by Barney Pityana).



The book is a product of presentations to a colloquium titled, *Mbeki@70*, hosted by the TMF and UNISA in 2012. The colloquium sought to address the matter of Afrocentricity in the process of knowledge production as a means of responding to Africa's challenges instead of positioning Africans as consumers of pre-packaged information from elsewhere.



## **PATRON'S ENGAGEMENTS**

ne of the TMF's central tasks, in addition to running our core and non-core programmes, is to provide administrative and other related support to our Patron, President Thabo Mbeki, on the various tasks he is expected to undertake on behalf of various parties, Countries, the African Union and other Multilateral Institutions.

Foremost among the work the AU has charged the Patron, is as the Chairperson of the High-Level Panel tasked with the resolution of security matters related to the Horn of Africa, the AU High Level Implementation Panel on Sudan/South Sudan and as member of the High-Level Mediation team to resolve the Lake Nyasa Border Dispute between Tanzania and Malawi.

In addition, the Patron continues to Chair the UNECA's High Level Panel, which is now tasked with the implementation of the Illicit Financial outflows from Africa Panel Recommendations on behalf of the AU/UNECA. The Patron also Chairs the Board of the South Center, an intergovernmental organization and Think Tank of developing countries, based in Geneva. The organization helps developing countries to combine their efforts and expertise to promote their common interests in the United Nations.

The Patron has made ad hoc interventions in such countries as, Kenya, Ghana, Malawi as Leader of the Observer Missions of the Commonwealth, and Zimbabwe, Comoros, Cote d'Ivoire and the Democratic Republic of the Congo.

The Patron also continues to be a valued and well sought-after speaker and advisor on various platforms and topics in South Africa, Africa and around the world and a critical player within the African Forum of Former Heads of States. The TMF maintains good relationships with individual journalists and media outlets in South Africa and beyond. Through interviews, press statements which are regularly


covered in popular press, and able to reach even bigger segments of society on TMF activities. This relationship has been strength


#### Social Media Platforms.




## **GOVERNANCE**

## Board of Trustees


